- START&FINISH:** 9:00 a.m. **SHARP** at Ocean Beach Park in New London. Plenty of free parking at the beach.
- COURSE:** 11.6 Mile measured loop. Mostly flat with a hill at eight miles. Course is well marked with plenty of water stops.

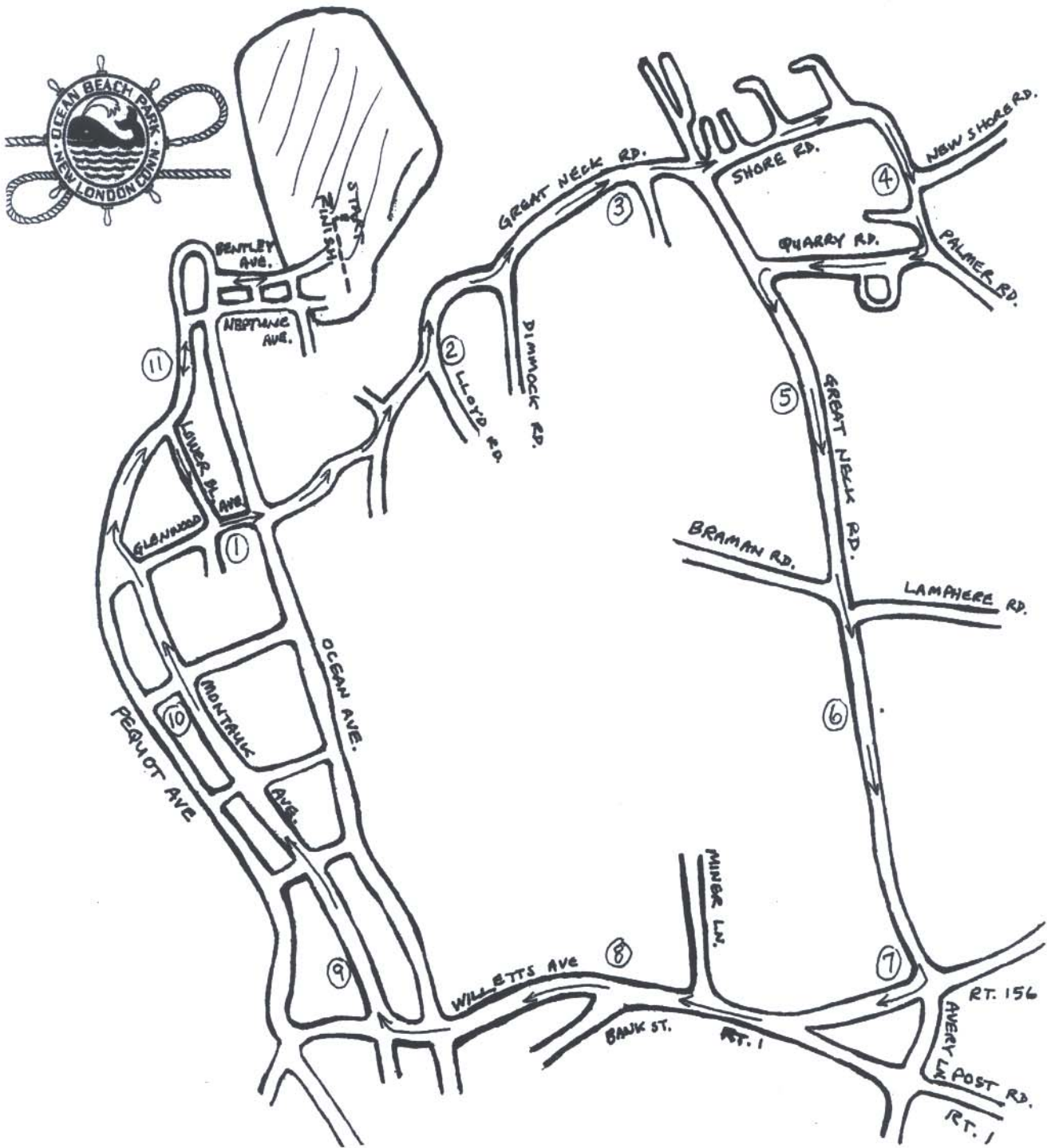
